Reading and Homework

Please encourage your child to access their logins on TT Rockstars, Spelling Shed, Dyslexia Gold and Reading Plus, as well as reading their reading books, as part of their homework each week. Little and often is always the best policy! Thank you for your support.

We have continued our reading reward system for children reading at home **five times a week**! Great start but it is never too late to join in!

Walk to School, Parking and Road Safety

Please park responsibility as we do not want there to be accidents or incidents.

Please walk to school if you can and either leave your car at home or **'Park and Stride'**. Y5 and Y6 children can walk to and from school, with your permission.

We also have a number of parents or family members attempting to park in the school car park. This is a polite reminder that this car park is for **staff and blue badge permit holders parking only**.

The children will be designing posters or leaflets (in the new year) to win more WOW badges to promote **'Park and Stride'** and walking to and from school.

In school, in the upcoming half term, we will be learning more about road safety/pedestrian skills, fire safety, stranger danger, vape and drugs awareness and internet/online safety.

Attendance

At the end of the last academic year, we were proud to have achieved a certificate for being in the **top 25%** of primary schools in the country for our attendance! Unfortunately, this term we haven't got off to the best of starts with many families taking holidays in term time.

Only 22 children have achieved a 100% attendance certificate this term. However, many families have been working with school and have received positive messages for working in partnership to improve their child's attendance. Thank you to all of you for your support.

Please be aware of some changes to the guidance from the Department for Education (DfE):

If the leave of absence has not been authorised by the Headteacher, the information will be submitted to the Education Inclusion Service who may issue a Penalty Notice or take other legal intervention if there are 10 or more consecutive or non-consecutive unauthorised absence sessions (5 days) within a 10 week rolling period. Penalty Notices were introduced as an alternative to prosecution but if they fail to act as a future deterrent, prosecution may be considered, rather than a further Penalty.

- If paid within 21 days, the Penalty Notice is £80 per parent or carer, per child
- If paid after 21 days, but within 28 days, the Penalty Notice increases to £160 per parent or carer, per child
- If the Penalty Notice remains unpaid after 28 days, this may result in prosecution.

The second time a Penalty Notice is issued within a three-year period for unauthorised absence the amount will be: £160 per parent, per child paid within 28 days.

The third time an offence is committed (within a three-year period) a Penalty Notice will not be issued and the case could be presented straight to the Magistrate's Court. Prosecution can result in Criminal records and fines of up to $\pm 2,500$. Cases found guilty in Magistrates' Court may show on any parent's future DBS certificate for to 'failure to safeguard a child's education'.
